## **POSITION PURPOSE**

The Blue Skies Landscaping Green Infrastructure Crew Lead is a full-time employment opportunity with Walnut Way Conservation Corp. supporting all aspects of the Blue Skies Landscaping program, as well as urban agriculture and campus maintenance. The candidate must possess knowledge and skills in landscape maintenance, landscape installations, horticulture, and agriculture, with a focus on green infrastructure practices. The candidate must be comfortable working outdoors in all temperatures and types of weather, and must possess sufficient physical fitness/strength to lift landscaping tools and materials. The candidate must also have at least 1 – 2 years' experience operating equipment such as masonry saws, plate compactors, tillers, backpack blowers and more, as well as have knowledge in both construction practices and plant identification. The Green Infrastructure Crew Lead should be friendly and dependable and be able to lead other staff as required, as well as have a strong attention to detail and ability to multitask. In all instances s/he must perform in accordance with and be committed to the Walnut Way mission.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES**

1. Arrive to work daily early and prepared to execute work assignments
2. Organize vehicles, equipment, tools and materials for the assigned daily project/tasks
3. Drive to project site(s) with crew, equipment, tools and materials
4. Conduct daily crew debriefs for work to be completed
5. Supervise designated staff on residential, commercial and municipal contracts, focused primarily on Green Infrastructure installation and maintenance
6. Safely and effectively operate and maintain a range of vehicles and equipment
7. Follow all protocols for safety, start and end of day activities
8. Maintain detailed and accurate records, including work logs, receipts, spreadsheets and others, submit reports on a daily basis
9. Meet weekly with Environmental Specialist, Supervisors and Leads to maintain records and perform planning for upcoming work
10. Support all aspects of Walnut Way campus maintenance (litter clean up, weed control, organization, minor repairs)
11. As directed, assist with all tasks related to agricultural production, such as bed preparation, sowing, weeding, pruning and harvesting
12. Potential to supervise winter service (snow and ice removal) contracts during the winter season
13. Attend all required trainings and obtain and maintain all required certifications
14. Other duties as assigned by Supervisor
15. Perform other duties to support the success of Blue Skies Landscaping and Walnut Way Conservation Corp.

## **SUPERVISORY RESPONSIBILITY**

This position requires on-site supervision of crew members and/or technicians assigned to the Green Infrastructure Crew Lead's work team for that day. Supervision includes, but is not limited to, safety, execution of tasks, task completion, and customer interaction.

## **ENVIRONMENT**

Candidate must be able to lift 75 pounds. Specific vision abilities required by this job include close vision and ability to adjust focus.

## **TRAVEL**

Local travel to project sites is required. For normal working hours, transportation is provided via company vehicle.

2. Demonstrates proficiency maintaining and operating small equipment such as such as bed edgers, tillers, plate compactors, brick saws, laser levels, hedge trimmers, backpack blowers and others
3. Demonstrated ability to perform algebra calculations, proficient with construction math
4. Ability to read tape measure, take field measurements and lay out plants and hard features per job specifications
5. Proficient interpreting landscape plans
6. Ability to identify both common hybrid and native perennials per Walnut Way resources as defined 75% proficiency in an identification quiz
7. Ability to identify common trees, shrubs and perennials and demonstrated knowledge of proper installation, care and pruning practices
8. Must possess WI Pesticide Applicator License: 3.0 Turf and Landscapes
9. Ability to become NGICP Certified within first year of employment
10. Must possess a valid Wisconsin Driver's License with a good driving record
11. Knowledge of safe barricading practices in active roadways
12. Must show high levels of honesty, personal integrity, and humility
13. Practices leadership by example
14. Ability to execute scopes of work; adjust as situations warrant; think on feet
15. Able to record work, labor and materials, document via paperwork, photos and tablet PC
16. Commitment to teach, train, develop and support coworkers
17. Ability to supervise, motivate, evaluate and discipline designated staff
18. Excellent customer service skills ability to communicate positively with clients
